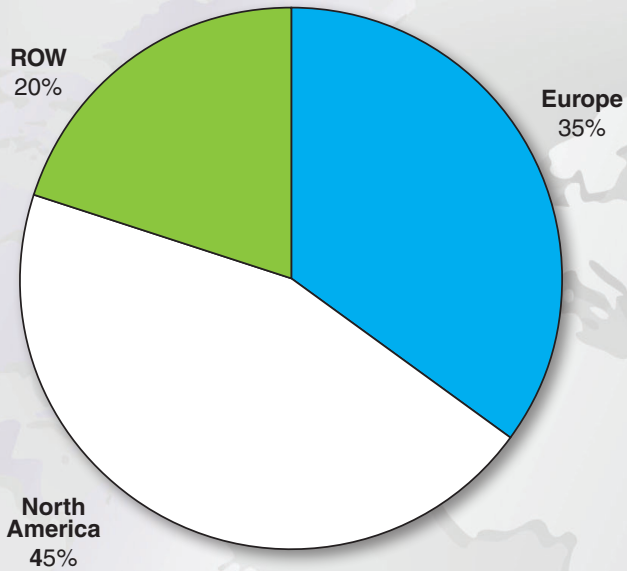

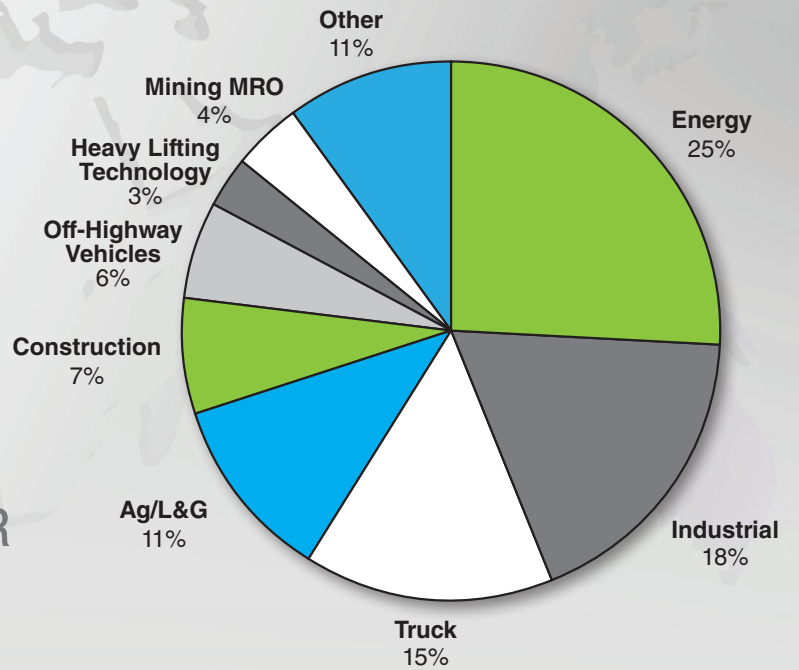

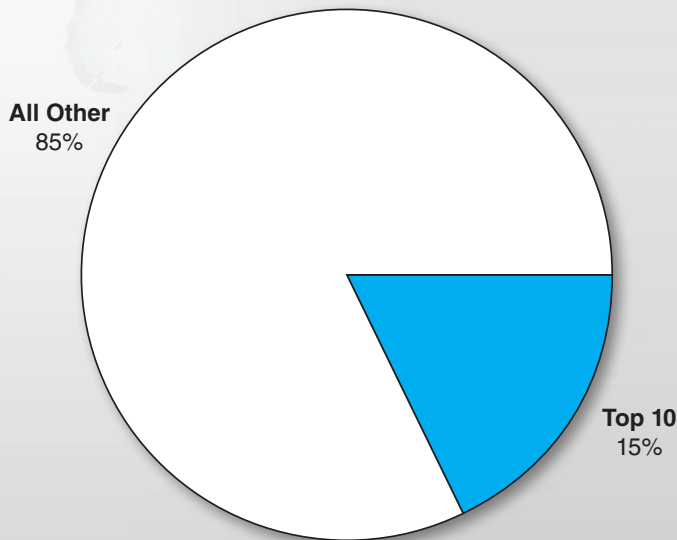
SALES BY GEOGRAPHY
